All Ordinary members will pay a base fee of \$600.00 per year. The balance of their dues will be calculated as follows and HST will be added to the total amount:

First \$5M @ \$0.3057 per \$1,000.00  
Next \$5M @ \$0.2038 per \$1,000.00  
Over \$10M @ \$0.1019 per \$1,000.00
